INDIGENT REGISTRATION – FINANCIAL YEAR 2023/2024

In terms of Section 74 of the Local Government Municipal Systems Act, act No. 32 of 2000 read together with the Indigent Policy of Greater Giyani Municipality notice is hereby given in that the municipality calls for residents, who qualify, to register as Indigent OR Pensioner for the 2023/2024 Financial Year.

Residents must meet the following criteria in order to apply for Indigent Support OR Pensioners rebate:

- a) Total household income must not exceed R 5 000.00 per month.
- b) Old age grants and the total monthly household income, excluding child support grants and foster care grants, is not more than R 5 000.00.
- c) Child headed households.
- d) Pensioners other than those receiving old age grants will only rebated on residential tariff for property owners.
- e) A household is defined as the applicant plus six dependants living together under the same house or dwelling.
- f) In the event that there are other persons including family members living in the same house or dwelling who are income earners but not dependant on the applicant with the exception of tenants, their income shall be included in the calculation of household income.

Registration is open from 3rd April 2023 to 18th June 2023 and registration process will not be extended.

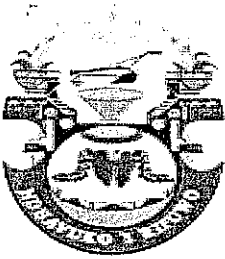
