Mayor takes residents into his confidence

Considerable progress has been made in the delivery of basic services since the advent of democracy almost 20 years ago.

This was said by Greater Giyani Mayor Cllr Patrick Hlungwani during a recent visit to Phikela village, where he toured several community projects and assessed the impact of the municipality's service delivery in the area.

Cllr Hlungwani said that despite numerous challenges facing the democratic government, there was a notable improvement in service delivery compared to the pre-1994 era.

"I am sure you will agree with me when I say that before 1994, services such as electricity and sanitation were unthinkable in rural communities," he said.

He assured the community that the municipality would do everything in its power to ensure that all its grievances and aspirations were adequately addressed.

The residents had complained about bad roads and the lack of jobs, among other major challenges.

FROM THE MUNICIPAL MANAGER'S DESK

Service delivery firmly on track

In the Winter Edition of **Rito**, we highlighted some of the progress that has been made as far as the delivery of various projects is concerned.

In this issue, we continue to highlight steps that have been taken or are being taken regarding the implementation of the projects announced by the Mayor, Cllr Patrick Hlungwani, during his delivery of the 2013-2014 Budget Speech in May.

The following is the progress report on some of the projects:

- The building of a restaurant at the Giyani Tourist Information Centre is complete and will be followed by processes to secure a service provider to lease the facility. Read all about it on Page 11 of this publication;
- The construction of an access road to the Giyani Tourist Information Centre is under way;
- The building of a new wing of the Giyani Civic Centre is about 40% complete;
- Contractors have been appointed and are finalising designs and the mapping of villages to electrify more than 2 000 households;
- A policy on spaza shops has already undergone the public participation process and is only awaiting council approval; and
- The Spatial Development Framework is under review. At present, communities are being consulted on the matter.

The following projects are out on tender for implementation:

- The paving of a road at Ndhen'ezu;
- A master plan is being developed for the revitalisation of the central business district (CBD) and adjacent areas;



Limpopo MEC for Roads and Transport Lehlogonolo Masoga puts the new system to the test.

- Contractors are to be appointed for the erection of "Apollo" lights in a number of villages;
- The development of a human settlement at B9 (Makosha) has been formalised;
- A grader to enhance the maintenance of roads to be purchased; and
- Five extra vehicles to be purchased to boost the municipal fleet and improve service delivery.

Having said that, it gives us great pleasure to announce that the recent by-election in Ward 8 to replace the late Cllr Relax Rikhotso was conducted successfully. Makoma Christinah Modjela was elected the new councillor.

Another significant development that took place in our municipality was the

launch of an electronic learners' licences testing system. See Page 13.

The development coincided with the upgrading of the Giyani Testing Station from B to A.

This means that the station will also have the capacity to test heavy duty vehicles and motorcycles.

Finally, as far as the municipality's human resources are concerned, a number of audit and risk officers have been appointed.

We hope these appointments will go a long way towards ensuring improved audit outcomes.

Speaking on behalf of Phikela residents and neighbouring communities, Headman Daniel Ngoveni said the parlous state of roads in the area was the biggest challenge facing them.

"More than anything, we need the roads to be graded as they are in a bad state.

"Buses have even changed the route because of this," he said.

Ngoveni, however, acknowledged the work that had been done by the

municipality in providing clean, safe and drinkable potable water.

But he added that old boreholes needed to be serviced as backup during dry spells.

"As you know, Giyani is a dry area. We need something to fall back on when the water from the dam runs out," he said.

Youth representatives appealed to the Mayor for quality permanent jobs, saying casual or temporary work was unhelpful as it sustained them for a short period.

"When these jobs end, the youths

turn to crime to fund their new lifestyle," said youth leader Basi Mun'wanati.

In his response, Cllr Hlungwani said he would see to it that the roads were expeditiously graded.

"We will also make follow-ups on some of the things that were promised by various departments that are here today to ensure that your needs are attended to," he said.

He promised the community that he would return in three months' time to assess the work and see if the promises made at the meeting had been fulfilled.

Revamped civic centre to enhance service delivery

In a move aimed at creating a conducive environment for effective and efficient service delivery, the Greater Giyani Municipality is expanding its civic centre.

The municipality is building the second administrative wing on the western side of the existing block to address the shortage of office space, which has forced many municipal workers to operate from rented offices in other parts of the town.

Some of the departments that have been affected include Supply Chain Management and Technical Services, which are renting office space at Limdev and Unigaz buildings respectively at a great cost to the municipality.

This move, a result of the increasing number of municipal staff, has negatively impacted on the pace of decision-making and administrative coordination. It has also affected the residents, who sometimes have to pay extra in transport costs to access municipal services as the rented offices are a considerable distance away.

Municipal spokesman Steven S Ma-

vunda said significant progress had been made in the construction of the new office wing, which is expected to consist of up to 50 offices.

The project is being undertaken in two phases.

The first phase, which will cost about R12 million, is expected to be completed in about 10 months from now.

"If things go according to plan, and depending on the budget, we are mostly likely to complete the project by August next year," Mavunda said.

Independent councillor Mkhari wins voter registration award

Petrus Mkhari, an independent Greater Giyani ward councillor, scooped the Best Performance of the Month Award for registering a total of 342 new voters in July. Cllr Mkhari walked away with a floating trophy and R1 000 cash for his efforts.

This came as the municipality intensified its campaign to get more potential voters on the voters' roll ahead of the 2014 general elections.

The municipality had since June this year been encouraging each ward to register at least 100 new voters a month.

Speaking during a ceremony at which Cllr Mkhari, of Ward 27, was presented with his prize, Greater Giyani Mayor Cllr Patrick Hlungwani called on other wards not to despair but to continue working hard.

Cllr Hlungwani said the six-month campaign would culminate in the awarding of a grand prize in November.

"We're going to consolidate the number of new voters that will have been registered since the campaign was embarked upon in June. Whoever will have

the highest total of registered voters will win the grand prize," Cllr Hlungwani said.

The ceremony coincided with a special council sitting to appoint a new municipal electoral officer (MEO).

Municipal Manager Gezani Isaac Masingi was appointed as the new MEO for Greater Giyani. The appointment was supported by members of the opposition, who said he was the right candidate for the position because he was not active in politics.

"We know which party he belongs to but the fact that he is not an active member makes him the right person for the job," said Ximoko Xa Rixaka representative, Cllr Alpheus Makamu, as he moved the motion for approval.

The motion was also supported by other opposition parties such as Democratic Alliance and United Democratic Movement, as well as independent councillors.

Masingi replaces Given Maluleke, who resigned after her contract as the municipality's Director of Community Services expired.

REGISTERED VOTERS IN NUMBERS

According to the IEC, Greater Giyani registered 1 664 new voters in July and a further 2 725 in August.

The August figure ranked among the highest in the province.

The IEC statistics also show that there are seven villages in Greater Giyani that are big enough to form their own wards. These are Siyandhani, Mavalani, Makhuva, Ngove, Mageva, Ndhambhi and Thomo.

They each have more than 3 300 registered voters, which exceeds the required number of registered voters to be considered a ward by more than 500.

As of 23 September, the ward that had the biggest number of registered voters was Ward 19, with a total of 4 775.

It was followed by Ward 18, with 4 653.

The ward with the lowest number of registered voters was Ward 30. It had, as of 23 September 2013, about 2 596 registered voters.

Risinga shows the world what Mzansi is made of

Risinga High School flew South Africa's flag high at the Students for Advancement of Global Entrepreneurship (SAGE) 2013 World Cup held in Abuja, Nigeria, recently.

Representing the whole of South Africa, the school acquitted itself well in the fiercely contested affair. It clinched the third position overall, beating powerful opponents such as the United States, Great Britain, Russia, South Korea, Canada, Kenya, Singapore and Rwanda.

The week-long annual competition was won by the host country Nigeria, represented by Abuja's Jikwoyi Junior Secondary School, which competed in the social enterprises business category. The second overall position was won by China.

Another African country that fared fairly well in the competition was Ghana, which finished fourth.

The SAGE World Cup is an international entrepreneurship competition in which teenage entrepreneurs from around the world showcase their innovative business and community service projects to a panel of judges.

The competition introduces learners to entrepreneurial initiatives by encouraging them to be innovative and identify opportunities that could help them to create jobs or provide sustainable income for themselves.

Risinga High School – represented by Tiyani Chavalala, Daisy Ngoveni, Bornwise Dube and Tirhani Bila – won the social responsibility business category, beating Nigeria's University of Calabar International Schools into second place.

The group's project involved staging events and organising shows and sharing a portion of the proceeds with a selected needy family.

By clinching the third position overall, the group walked away with \$500 (about R4 950).

In an interview with **Rito** on their return, the elated four learners said their experience during their stay in Abuja was worth more than the prize they won

Before their departure for Abuja, Greater Giyani Mayor Cllr Patrick Hlungwani gave each of them R2 000 spending money.

"The money that the Mayor gave us really came in handy. Although R1 gave us 16 to 17 naira, things out there are

way too expensive. We don't know how we would have enjoyed that trip without the Mayor's assistance," said Tiyani.

Outside the competition, the four had the opportunity to learn about the Nigerian culture.

"We also had the opportunity to meet different people from different countries and exchange numbers with them. We hope this will give us an advantage when we go into business abroad in the future as we're already globally connected," quipped Bornwise.

Their principal, Moses Maswanganyi, was over the moon with the group's achievement in the competition.

"If you are in a school where both the educators and learners have a common goal, you are bound to succeed," he said.

Mayor's plea to Deputy Minister Manana: Reopen Giyani College

Greater Giyani Mayor Cllr Patrick Hlungwani recently asked the Deputy Minister of Higher Education and Training, the Honourable Mduduzi Manana, to fast-track the reopening of the Giyani College of Education.

The Deputy Minister was speaking at Letaba Further Education and Training (FET) College as part of the government's programme to encourage matriculants to enrol at FET colleges to improve the number of artisans in the country, which is on the decline.

During his remarks to introduce the Deputy Minister to the audience, Cllr Hlungwani asked Manana to consider reopening the teacher training college.

"Giyani College used to be one of the best teacher training colleges in Mopani and the entire province. We have heard that the Department of Higher Education and Training is considering resuscitating some of the colleges of education in Limpopo. According to the information

we have, the former Giyani College of Education is one of those colleges that have been earmarked for resuscitation," he said.

"As a municipality, we are acutely aware that one of the government's major priorities is education, hence our request for the reopening of Giyani College. We are serious about education.

"We're not saying we're not pleased with the vocational training that is taking place at Letaba FET College. However, as a municipality, we believe we could complement that with what we have in this college by channelling other curriculums to it," he went on.

The Mayor concluded by inviting the management of the Letaba FET College to communicate with his municipality.

"There are many issues that require our engagement, which could improve the lives of the students," he said.

Computerised licensing system aims to curb corruption

A state-of-the-art testing system for learner drivers – the first of its kind in Limpopo – has been launched in Giyani.

Unveiled by Limpopo MEC for Roads and Transport Lehlogonolo Masoga, the new system cuts off any form of contact or relationship between the applicant and the instructor, thereby eliminating possible fraudulent or corrupt transactions.

"At the booking stage, the learner is digitally thumb-printed and photographed and the image stored in the on-line system's storage facility," the MEC explained.

"When the applicant returns to take the test, he or she will have to match the digitally stored information in order to be allowed to take the test."

Masoga said this would do away with instances in which an instructor would, for example, write a test for the applicant.

This and other forms of corruption had in the past resulted in many people being issued with learner driver's licences illegally.

The system also marks and processes the application upfront and puts the in-

formation online, eliminating paper work completely.

Masoga also said that the provincial department was in the process of developing technology to prevent other forms of corruption, such as bribery at the licence-issuing stage.

A number of investigations into these illegal activities were under way in several testing stations in the province, he said.

"It is a shame that there is collusion between driving schools and licensing officials in the issuing of fraudulent licenc-

es. We have to eliminate corruption and safeguard driving standards," he said.

Welcoming the new system, then Acting Greater Giyani Mayor Cllr Million Rikhotso said he was delighted that the municipality was the first in the province to use the new system.

"Instead of worrying about losing revenue as applicants move to other areas for the so-called 'easy-to-pass' tests, ours is to work towards mastering the system so that we are on top of the situation by the time it is rolled out to other areas," Rikhotso said.

The group scooped the top prize after winning the awards' Top Entrepreneur category.

Members of the project sell their chickens to a number of small local businesses as well as various communities in and around Giyani.

All position one winners were each presented with a trophy and a R4 000 cash prize.

First runner-ups each became R3 000 richer, whereas second runner-ups were presented with cheques for R2 000 each.

The lavish ceremony was addressed by a number of speakers, including Maria Mabunda, the 2012 overall winner of the awards.

"Farming is not just a job, business or career but a calling to serve the community around you," Mabunda told the guests who had gathered in the hall to witness one of the most important events on Greater Giyani's calendar.

Mabunda said women farmers worked under very difficult conditions that at times forced them to consider calling it a day. She said, however, that they could not do so as there were many people who depended on them
